## *The following is hereby exposed*

This contract governs the use of the typeface and the fonts composing it, as described on the web pages of the Emilie Vizcano website. Our products are not sold, but are licensed to you as end user. This End User License Agreement (EULA) governs the use of Digital Font as presented on the pages of emilievizcano/foundry and/or any Emilie Vizcano's catalogs.

It is concluded between you (hereinafter: the End user) and the Licensor Emilie Vizcano. By paying, downloading, installing and/or using Digital Fonts, you confirm that you have read and accepted the terms of this agreement whose terms bind you legally to Emilie Vizcano and that you have the legal capacity to contract.

Should you not accept the conditions above and below, do not purchase, access, download and/or install or otherwise use the Digital Font(s). If you do not agree to this License, you are invited to discuss the issue with the Licensor. The Licensor is an independent design studio that thrives by keeping customers satisfied and is open to new ways of providing a better service.

## *Intellectual Property*

The Licensee acknowledges that the Fonts, trademarks, copyrights, including the copyright of the typeface, and any other intellectual property rights related thereto, are the exclusive property of the Licensor, and are protected by copyright and other intellectual property laws. The Licensor remains the sole owner of the title, copyright, and other intellectual property rights in the Fonts and the Licensee does not acquire any ownership rights in the Fonts.

## *Licensing Model*

We grant you a perpetual, non-exclusive, non-transferable license to use our font software. We have three (3) types of licenses. The Print License, the Web License, and the Full Brand License.

We base our prices on the size of your company or your client's company, with the number of employees being the only factor considered rather than the size of the design agency, design department, or number of font users. Our font software are available in perpetual licenses (S, M, L, XL, 2XL). With a purchase, you own the right to use the font software.

## *License & Access Authorizations*

### PRINT LICENSE

A license is required for anyone using the fonts. Our licensing is simple, we offer 3 types of licenses: Print, Web/Socials/Apps and Full branding. The pricing is based on the company size, it means the TOTAL number of people who work in your organization - not how many users will use our fonts in your company.

### WEB LICENSE

The Web license is needed for any website, microsite, subdomain, social media or apps, where the font is embedded. You will need the license to reflect the anticipated total monthly pageviews of all domains, microsities and/or subdomains for this specific client or campaign.

### WEB LICENSE

The Full Brand license is needed for anyone wanted the both Print/Desktop and Web/Socials/Apps purposes (see above). You will need the license to reflect the anticipated total monthly pageviews of all domains, microsities and/or subdomains for this specific client or campaign. The license coverage should reflect the total amount of workstations that will have the font installed.

## *Comptability & Usage*

Emilie Vizcano offers desktop font formats in OpenType (.otf) and TrueType (.ttf). For webfont packages, only WOFF (.woff) and WOFF2 (.woff2) font files are included. The font softwares downloaded from the website are guaranteed to be valid, installable and printable. Emilie Vizcano tests the OpenType layout features independently, but the support of these features depends on the systems, software versions, or browsers. It is recommended to refer to the relevant documentation for your system, software or browser.

## *Conditions of use*

### GENERAL CONDITIONS

The Licensee may not use the Fonts in any manner that would (i) infringe the permitted uses outlined in the License or in a way that does not fall under the permitted uses under this License (ii) provide access to the Fonts to third-parties or (iii) infringe applicable legislation or regulations especially, intellectual property (especially copyright) or violate any other local, federal or international law. The Licensee is responsible for choosing the right License for its intended and actual usage of the Fonts.

### PREPRESS ALLOWANCE

The Licensee can send the Fonts to their printing services, but after the job has been completed the Licensee must ensure that the service providers remove the Fonts from their systems to ensure they do not end up using them on other jobs.

The Licensee is responsible for the use of the Fonts by third party to which it has given access to the Fonts.

### EMBEDDING PERMISSIONS

The Licensee can embed the Fonts in certain electronic documents. This includes PDF, Flash and Microsoft Office documents (such as Word or PowerPoint), or multimedia files. Unless express written consent has been obtained from the Licensor, the Licensee cannot embed the complete character set as fonts embedded in electronic documents.

### BACKUP COPY

The Licensee can keep one backup copy of the Fonts they have licensed, but the backup medium they use should be secure and only privately accessible.

### PROHIBITED USES

The Licensee is prohibited from:

- (i) Distributing copies of the Fonts or make the Fonts available to any unauthorized third-party;
- (ii) Uploading or downloading the Fonts on the internet or making it available publicly in any other way, which include uploading the Font to a public internet file transfer or storing channel
- (iii) Reselling, renting, giving, leasing, transferring, passing title, sublicensing the Fonts through any medium, in whole or in part, to any third-party or anyone else that is not a user authorized under the License.

Under no circumstances may you convert, modify, reverse engineer, decompile, or disassemble the original font software from Emilie Vizcano's. You may not manipulate the font in any way that would reveal its structure, organization, or code, or open the original font software in an editing software for this purpose.

You may not use the original font software from Emilie Vizcano to create a derivative or modified product or design, including creating characters for alphabets and languages not covered by the typeface or designing a custom version of the typeface. Even if converted to outlines with the help of an editing or design software, you may not modify the design of the characters contained in the font software from Emilie Vizcano.

In the event that permission is given to you for a modification or a custom version of the typeface from Emilie Vizcano, any and all modifications and additions shall become and shall remain the sole and exclusive property of Emilie Vizcano. ### Self-Checking & License update

Ensuring that your license is always up to date is crucial. Please notify us of any changes in the number of employees in your organization and update your license accordingly, at least once a year. Please note that we may also perform periodic internal checks using publicly available database information.

### Updating your License

It's crucial to confirm that your license is current if there have been any changes to the size of your company since your initial purchase. We conduct regular checks to ensure compliance, and to maintain the validity of your license, it's necessary to get in touch with us to upgrade your fonts.

### Copyright & Trademark

Our font software is owned by Emilie Vizcano and protected by copyright law. The intellectual property of the design contained in the font softwares is owned by Emilie Vizcano. You have purchased a non-exclusive, non-refundable license which grants you certain rights to use the font softwares. It is not an agreement for sale of the font software, of its design or any portion of it. Except for your rights to use the font softwares granted by this license, all other rights are owned and retained by Emilie Vizcano.

### Credits & Fonts in use

The end user of this License agrees to do his best to credit Emilie Vizcano in conformity with the French Intellectual Property, Code and international conventions and to the copyright regulations by indicating:

We reserve the right to showcase and share the ways in which our fonts are utilized. This may include sharing on social media, displaying on our website, featuring in books, magazines, lectures, case studies, and allowing third parties such as design magazine publishers to do the same. However, this will only be done for projects that are already public and images that are freely accessible. Whenever possible, we will always credit the authors of the projects. ### Buying a font for a client

A license is required for anyone using the fonts. If only the designer has access to the fonts, then only the designer needs to obtain a license. However, if the client also needs to use the fonts, both the designer and the client must possess a license.

As a payment facilitator, you have the option to purchase font files for your client. However, it's important to note that your client should always be the license owner. This option can be beneficial in certain situations, as it ensures that your client can use the font files in their projects and maintain their business operations smoothly. By handling the font file purchase, you can assist your client in saving time and energy, allowing them to concentrate on their primary business activities. It's crucial to keep in mind that your client is still responsible for adhering to the licensing terms and conditions.

If you're a designer, design agency, or advertising agency, and you purchase a license for a digital font, your ultimate end user (your client) must purchase the corresponding user license for their intended use of the font, based on their company size. For example, if you're a freelancer who works for Nike, Nike needs to purchase the license based on their company size, rather than the number of users who will use the font on your project.

You can purchase a license on behalf of your client, but your client must first accept this EULA before downloading and installing the digital font. Additionally, if you're an agency or studio working on behalf of your clients, you do not need to purchase the corresponding license for your own use. However, the original license does not extend to temporary employees or independent contractors who are using the desktop license of the digital font. Emilie Vizcano reserves the right to amend or modify this End user license Agreement at any time without any prior notice, in order to account for future commercial and technical changes.

### Miscellaneous

This contract constitutes our complete agreement and replaces any previous agreements or discussions. Any changes to this contract must be in writing and mutually agreed upon. If any part of this agreement is deemed unenforceable, the other terms will still apply, and the unenforceable part will be replaced by a similar enforceable term. Our decision to waive a right or allow an action at any point does not imply that we will do so again in the future.

### Entire Agreement

The License with respect to the Fonts constitute the entirety of the agreement made between the Licensee and Licensor.

### Applicable & Law Jurisdiction

This agreement is governed by Swiss law with exclusive jurisdiction in France, and any legal disputes will be resolved in France.

The United Nations Convention on Contracts for the International Sale of Goods and the United Nations Convention on the Law applicable to International Sales of Goods do not apply. You are responsible for any taxes incurred in your country, including withholding taxes, and they will not be deducted from your payments to us.
